## F.E.R.I. (Fiche Electronique des Renseignements a l'Importation) **DEMOCRATIC REPUBLIC OF CONGO**

According to Notice no. ADG/ADT/DFL/FAC/No. 004/BB/04/2008 dated 22 April 2008 with immediate effect. The "Office de Gestion du Fret Maritime, OGEFREM" wishing to cover all loading ports in the world to implement the F.E.R.I. Any cargo with Final Destination at Democratic Republic of Congo disregard whichever transshipment port (e.g. Dar es Salaam, Mombasa, Durban etc.) and port of discharge (e.g. Matadi), must be covered by the validated F.E.R.I. Any cargo not covered by the validated F.E.R.I. constitutes an offence to the regulation in force in RDC, heavy penalties will therefore be applied at destination. Application must be made with the authorized agent covering the port/country of loading.

### Tariff :

**EUR 40.00** per F.E.R.I. issuance & validation  
**EUR 60.00** per 20' container  
**EUR 110.00** per 40' container  
**EUR 0.50** per MT or CBM whichever is greater for bulk cargo of basic food / pharmaceutical / petroleum products, mineral water and gray cements.  
**EUR 4.00** per MT or CBM whichever is greater for general cargo, RORO, vehicles, LCL cargo.

### Documents required :

1. **Bills of Lading** (draft BL can be accepted for time being, Not Negotiable, Verify copy or Original copy must be provided for final validation)
2. **Commercial Invoice** (must stamped & signed)
3. **Freight Invoice** (if freight value not stated in the commercial invoice)
4. **Packing List**
5. **Customs Export Declaration**
6. **Application Form**

*\*Every document needs to be uploaded into the system separately, so please split the file individually otherwise we need to print and re-scan. Thanks!*

All FER I application must be finalized and it can only be issued/validated before vessel's arrival at port of discharge.

FER I must be validated before the arrival of the cargo at destination, and in any case before the ETA date as indicated on the FER I. Otherwise, it will be subject to penalties at destination by OGEFREM.
